Alan Brown Cadillac-Oldsmobile GMC, Inc.*, 10th Dist. Franklin No. 02AP- 937, 2003-Ohio-6363, ¶18. The exception is based on case law which holds that the litigant who prevails should be awarded costs incurred on appeal. Id. R.C. 2323.51 provides that a trial court has the discretion to award costs on appeal to the prevailing party. The decision to award appellate fees and costs is subject to an abuse of discretion standard of review. Id. at ¶19. While appellants assert that appellee has not prevailed on appeal because the decision of the trial court was in their favor, as discussed above, this court has affirmed in part and reversed and remanded in part the decision of the trial court on the merits. Therefore, appellee has prevailed on appeal and can seek appellate fees. Accordingly, appellants' second assignment of error is overruled.
